Witnesseth:

Said compensation shall be paid in monthly installments on the 25th day of each month for the performance of the extra duty assignment, beginning in the month of **September 2018**, and ending in the month of **November 2018**.

STATE OF IDAHO SUPPLEMENTAL CONTRACT FORM

THIS AGREEMENT, Made this 28th day of August year of 2018, by and between Salmon River Joint School District No. 243, Riggins, Idaho ("the District"), and Charlie Shepherd ("the Employee"),

WITNESSETH:

The District hereby contracts to hire the Employee to perform an extra duty assignment as provided in the job description as Varsity Football Coach for a period of 2018-19 Season, at the compensation rate or fixed amount of THREE THOUSAND FIVE HUNDRED DOLLARS (\$3,500.00) until the Employee's contract has been fulfilled. Said compensation shall be paid in monthly installments on the 25th day of each month for the performance of the extra duty assignment, beginning in the month of September in the year of 2018, and ending in the month of November in the year of 2018. With and extended contract of \$200.00 per week past the regular season not to exceed three weeks or \$600.00.

EMPLOYEE will, at all times, faithfully perform all of the duties that may be required pursuant to the express and implicit terms hereof, to the reasonable satisfaction of the District. Such duties shall be rendered at District premises and such other place or places as the District shall in good faith require or as the interests, needs, business or opportunity of the District shall require.

The Terms of Employment of this Contract shall be in effect as given above for the length of time and extra duty expected, and are separate and apart from any certificated employee's regular duties and any Category A, B, Continuing or Retired Teacher Contract.

No property rights shall attach to this Contract.
