Most Economical Consolidation Option

- Divide the IEN room into two classrooms 620 square foot rooms with 85 square foot storage for each room.
 - o Will require electrical and computer updates.
- Move weight room to either the:
 - o Jr. High locker-room
 - o Football concession stand
 - Football storage
- Return current weight room back into a classroom
- · Remodel the current Jr. High building hallway
 - Remove lockers
 - Put up bulletin boards
 - o Ect.
- Remodel the rooms between the current Ag classroom and the shop into a new classroom for AG
- Add playground to the south side of the IEN and Jr. High building.
 - o Prep work
 - o Move part of the current playground equipment and add a new set of swings

Eric Hook motioned to accept the presented "Most Economical Consolidation Option" if and when needed. John Pottenger seconded. Discussion followed.

Eric Hook amended the motion to accept the presented "Most Economical Consolidation Option" if and when needed with the intent to provide fully functional classrooms. Richard Friend seconded the amended motion. Amended motion passed unanimously.
